# Environmental management/features

Grand National comprises approximately 270 acres of managed turf, 600 acres of water that is the city water supply, all on 1600 acres of Opelika Water Works Property. Water testing has been done three times per year for 24 years with outstanding stewardship and water quality protection records.

## Water conservation, management and/or controls:

Grand National updated its irrigation control systems and installed part circle heads on greens. GPS mapping of the course has provided moisture mapping info, which is utilized with soil sensors to manage watering to zones in need of additional water. The course also recently added native grasses to eliminate irrigation needs to those area.

# Abnormal weather conditions/occurrences in the last 12 months that affected the course:

An unusually cold spring has delayed the green up of bermudagrass and shortened the growing season.

### Unusual wildlife on the course

Numerous fox and squirrel in varing colors

### Predominate species of trees on course:

Loblolly pines

### Interesting notes about the course:

Grand National has two rock chimneys from past structures located on the property, one of which was a two-room frame house in which Johnny Lipscomb and his wife Bessie Johnson lived and raised 17 children. Johnny's father, Henry Lipscomb, bought the property now the lake and golf course for about one-dollar per acre. The family sold the property (about 1200 acres) to the City of Opelika water board in the early 1940s. In 1944, the dam was started which created the lake as seen on the property today.

### Comments overheard about the course:

Most golfers are amazed at the amount of water on the property and ask whether it is naturla or man-made.

### Significant changes recently made to the course:

The Lake Course greens were no-till renovated in 2011, switching from bentgrass to Champion ultradwarf. In 2014-2015, addition and renovations of tees to tournament holes No. 3,4,5,6,7,8,9,10,14,15,18 (front and back nines are reversed for the event except No. 9 and No.18 will play as is). Drainage installation and repairs on tournament No. 2., as well as bunker sand replacement on all 53 bunkers with one bunker removed.
